# What are Title V MCH Programs?

Title V programs are federal/state partnerships aimed at improving the health of mothers and children. These programs, which exist in every state and territory, were established in 1935 as Title V of the Social Security Act (SSA). In 1981, Title V was converted to a block grant, and states and territories had to create services to specifically address the needs of children with special health care needs (CSHCN). The amount of federal funding each state and territory receives is determined by the proportion of low-income children in the state or territory compared to low income children in the U.S. For every \$4 of federal funding, the state or territory provides \$3 in matching funds. At least 30% of each state's or territory's block grant must be spent on CSHCN.

### MCHB Definition of CSHCN

The Maternal & Child Health Bureau defines CSHCN broadly as "those who have or are at increased risk for a chronic physical, developmental, behavioral, or emotional condition and who also require health and related services of a type or amount beyond that required by children generally.\(^1\)" This inclusive definition describes a lot of kids; approximately 15% of all children under the age of 18 in the U.S.

# Title V/CSHCN Program Eligibility & Services

Because Title V programs are funded by block grants, there are limits to the numbers of children they can serve. This is why many Title V/CSHCN programs define CSHCN less broadly than the MCHB definition.
